IBTTA Exhibit Terms and Conditions

- Booth assignments will be made by IBTTA on a first-come, first-served basis. Floor plans are only available for the Annual Meeting. All efforts will be made to accommodate booth preference but the Association reserves the right to make choices based on the best use of the available space and the entire exhibit area.
- Full payment is required before Exhibit Space will be reserved. All fees must be paid in U.S. dollars and drawn on a U.S. bank. Payor must assume all bank fees. You may send this contract by fax only if paying by credit card. Checks should be made payable to IBTTA. Please reference delegate name and conference name and fax a copy to IBTTA at (202) 659-0500. For assistance with bank/wire transfers, contact Harry Smith at (202) 659-4620.
- Your organization's 2010 IBTTA membership dues must be paid in full to qualify for the member-discounted exhibitor rate.
- All Exhibit Space cancellations must be made in writing. Cancellation of exhibit space 30 days prior to meeting will result in a penalty of 50% of cost; 15 days will result in a penalty of 100% of cost. This policy will be strictly enforced.
- The playing of music or loud noises within the exhibit or display area is strictly prohibited.
- Exhibitor shall affect insurance coverage for all exhibit merchandise at site and in transit exclusive of business interruption insurance, if applicable, and IBTTA shall not be responsible for any loss or damage thereto, howsoever incurred. The Exhibitor must carry his own insurance and public liability insurance of not less than one million dollars and provide proof of insurance to IBTTA prior to move-in. Please note the hotel may check for this when you move in, so be sure to have proof of insurance with you onsite.
- IBTTA will follow the official Guidelines for Display Rules and Regulations as issued by the International Association of Exposition Management. A copy of these rules may be requested from the IBTTA office.
- Installation and dismantling of Exhibits may only be conducted during the time specified.
- IBTTA will provide non-stop security from setup through tear-down, where necessary.
