Timeline

January 2021 – First meeting called by IBTTA President Mark Compton to discuss the merits and potential contributions of a possible Task Force on Sustainability & Resilience.

February 3 – IBTTA held a CEO Roundtable to discuss environmental stewardship, climate change responses, sustainability programs, and resilience initiatives.

- 35 Executives attended
- High level of interest and engagement
- Positive feedback

March 2 – IBTTA's President appointed Pedro Costa and Steve Snider to serve as Task Force Co-Chairs supported by Mark Muriello as IBTTA's staff liaison.

March 18 – First Governance meeting to discuss Scope, Mission/goals, Planning and the next steps.

May 1-7 – Survey of Task Force members' priorities and interests.

May 10 – Initial Task Force meeting with volunteer participants.



Survey of Task Force Members

- IBTTA conducted on on-line survey of Task Force members to understand the interests and priorities of the members
 - Results to help guide actions and agenda for the Task Force
 - Best practices and pitfalls to a avoid
- Survey was open for one week (May 1-7)
- 14 completed surveys received
 - 88% response rate

10 respondents expressed a willingness to share these policies with IBTTA.





Survey Results: Topics of Greatest Interest


What S&R topics are of the greatest interest to you?

Survey Results Top Four Task Force Achievements




Sustainability

Task Force Goals/ Objectives:

1. Raise awareness to the problems of Sustainability & Resilience.

The task force in-itself is a first step towards recognizing that Climate Change is real, and not because it is fashionable, but because it is existential – IBTTA website; *Webinars; S&R Award; IBTTA Strategic Plan; Speakers;...*

2. Be IBTTA's Champion for S&R and help Members get on board with the changes that are needed and likely coming.

In the wake of "Wokeness", we have a responsibility to unequivocally show we are on the right and that IBTTA and the Tolling community in general, are supportive of policies and initiatives that promote Sustainability and Resilience. Get the word out – *Statement; Advocacy; Policy; Media/Communication outreach...* Link.

3. How to be part of the change? Help IBTTA members navigate through the changes.

We still do not have the answer, but hope, with the help of our Members, to eventually have it and be able to share it with others – *White Paper; Road Map; Depository,...*

Task Force Goals/ Objectives:

4. Help Promote and Share experiences and initiatives on S&R.

Find best practices in our industry, incentivize members to act and share their initiatives in S&R – *Roundtables; IBTTA networking events; Webinars;...*

5. Identify trends and how they might impact Members.

Whether it is policies or behavioral changes, we should be able to identify those that will impact our businesses – Colorado legislature enacted legislation mandating – *Invite S&R expert speakers; IBTTA Events; Monitor legislative initiatives impacting tolling;...*

6. Turn intentions into meaningful actions. Avoid "Greenwashing".

We should mean it when we say it. For the most part many current ESG initiatives are strictly on paper. But change costs money and we need to "Bring your Board on board" and seek S&R funding. Present it as an **opportunity** to advance tolling as a way to help financing the change to a green economy – *Identify available funds/grants; Best Practices; Fact-Sheet making the case for tolling under S&R; ...*

Entry Requirements

- Applications shall be for a project or program that has produced successful, measurable results.
- Your organization must be an IBTTA member in order for your submission to be considered.

Submission Timeline

- Submission Period: April 14 June 14
- Submission Deadline: Your COB, Monday, June 14
- Winner Notified: Mid-late July
- Awards Ceremony: 89th Annual Meeting & Exhibition, October 10-12, 2021 (details to follow)

2021 Submission Evaluation Criteria

Each application is evaluated according to four criteria by a panel of 9 judges:

Criterion 1 (25%): To what extent are there results to demonstrate that the objective was reached and that it had a positive impact?

Criterion 2 (20%): How is the project relevant to promoting diversity, equity, and inclusion?

Criterion 3 (35%): To what extent does the project/program or organization clearly represent excellence in diversity, equity and inclusion?

Criterion 4 (20%): How innovative or sustainable is the project/program or organization?
