Florida's Turnpike Enterprise to Hold Industry Forum

OCOE, Fla. – The Florida Department of Transportation, Florida's Turnpike Enterprise will conduct a virtual and in-person Industry Forum at 1:30 p.m. Wednesday, February 24, 2021, to provide an opportunity for interested firms to learn more about the Department's Commercial Back-Office project.

The Department is preparing to procure an account management and financial accounting system with services to develop, integrate and transition to a new Commercial Back-Office system. It is anticipated that the new system will maintain customer accounts, process customer payments, generate customer billing, interface with the Department's SunPass.com website and SunPass® mobile application, and interface with the Department's interoperable partners. The Department is interested in leveraging commercial off-the-shelf products for the new system.
