SUSTAINING AND ASSOCIATE MEMBERS

Agencies, firms, individuals and other entities with an interest in some aspect of the toll industry. Associates do not own or operate toll facilities. Sustaining members receive additional recognition for their vital contributions at IBTTA events.

- SUSTAINING MEMBER:** Company's toll-related revenue is greater than \$5 million = **\$18,000**
- ASSOCIATE MEMBER:** Company's toll-related revenue is \$1 million to \$5 million = **\$9,200**
- ASSOCIATE MEMBER:** Company's toll-related revenue is less than \$1 million = **\$2,800**
- ASSOCIATE MEMBER - DBE/WBE/MBE/SBE LEVEL:** Company's toll-related revenue is less than \$1 million = **\$995**
*Business Entities that are certified as Disadvantaged or Woman-owned or Minority or Small **must submit proof of DBE/WBE/MBE/SBE status** with either a state/federal certificate or a letter from a transportation system which states that the organization has been awarded a contract based on its status; and must have annual gross toll-related sales of less than \$1,000,000.*
